- d. Lancaster Historical Society and Museum (40 Clark St.) J. Allein brought to the HPC's attention that a window on the front of the building has been blown out, as well as his concern for the care of the contributing building to the Central Ave. Historic District on the National Register of Historic Places. Several other Board Members voiced their concern as well. M. Meyer will draft a letter to the Town Board voicing the HPC's concern about the condition of the building and that it is a public safety issue as well.
