Roll call indicated that six (6) voting members were present and a quorum existed.

#### II. Public Hearings:

a. 5424 Broadway – Joga Singh – Signage

Mr. and Mrs. Singh were present. The proposed work includes replacing the middle portion of the existing sign – where the gas prices are displayed – to a programmable LED sign. The Board needed clarification of the extents of the work. M. Meyer stated that because the sign will not be rapidly changing or flashing, he had no problems with this type of LED sign.

- b. 5465 Broadway Barbara Wawrowski Fencing

- d. 5 West Main St. Kari Frank/Rocco Santoro/Tommy Sweeney Signage Mr. Sweeney was present. Allein questioned the height of the sign on the façade of the building, Mr. Sweeney informed the Board that the sign will be at least twelve (12) feet off the sidewalk, which conforms with the Village Code.
