## MEETING MINUTES June 14, 2017

#### I. Attendance/Call to Order

The meeting was called to order at 6:59 PM by Chair M. Meyer.

Roll call indicated that seven (7) voting members were present and a quorum existed.

### **II.** Public Hearings:

a. 31 Central Ave – Cayuga Flow Yoga Studio, Alex Severyn– Exterior improvements

Mr. Severyn was present at the meeting. The proposal includes a flat exterior grade wood-like board sign 2'-0" x 8'-0" and 2 gooseneck lights above. M. Meyer asked where the lights will go on the façade of the building, A. Severyn stated they will be centered beneath the two center windows. The second part of the proposal was for alleyway lights strung across the two alleyways between 31 Central Ave and the two adjacent buildings. These lights will be white exterior lights and will be on a timer. J. Allein stated that one of the alleyways is a street for cars to get to the parking lot and that A. Severyn should check with the Code Enforcement.

MOTION: S. McNichol motioned to approve the CoA as presented. J. Allein made an admentment to the motion that the CoA have the condition attached that the owner receive approval by Village Code Enforcement for compliance of the alleyway lights over village property. Second by E. Eckert. MOTION APPROVED: In a vote of six (6) ayes to zero (0) nays. J. Keefe abstained from voting as the property owner is a client of his.

Justification: The signage and lighting are compatible with the aesthetics of the historic district.

b. 5441 Broadway – Tom Fowler – Removal of trees

Mr. Fowler was present at the meeting. He explained the proposal to remove all the trees from the back of the property due to the numerous problems they are causing for the neighbors as well as the integrity of the historic building at the property itself. S. McNichol asked if there were plans to plant new trees in place of the ones being removed. T. Fowler said that there is no plan to replace the trees.

MOTION: J. Keefe motioned to approve the CoA as submitted. Second by S. McNichol.

MOTION APPROVED: In a vote of seven (7) ayes to zero (0) nays.

Justification: The trees are interfering with the maintenance of a historic structure in the district as well as creating problems for properties in the district.

c. 1 West Main Street – Crystal Newman, Bloomsbury Lane Toy Shoppe– Exterior painting

Ms. Newman present at the meeting. She explained plans to paint the deteriorating aluminum around the storefront windows at the shop. E. Eckert stated that the building owner corresponded with the HPC to assure the commission no painting would be on the newly repaired brick on the exterior.

MOTION: E. Mikula motioned to approve the CoA as presented. Second by M. Meyer.

MOTION APPROVED: In a vote of seven (7) ayes to zero (0) nays.

Justification: The exterior paint is compatible with the aesthetics of the historic district.

  - ii. 31 Church St. The bracing holding up the porch roof remains after at least a year.
