#### **a.** 30 Central Ave. (the 3 Dog Barber) – Kevin Kraus – New Signage

Mr. Kraus was present at the meeting. The COA Application included a flat sign above the storefront, a barber pole to be mounted to the left side of the door, a pedestrian sign on a bracket to be mounted to the right of the door and 5" vinyl lettering to be placed at the top and bottom of the windows of the shop. T. Sweeney asked what the flat sign will be made of – K. Kraus responded that it will be a flat, metal sign. Gooseneck lamps exist on the building; therefore, no lighting is included in the COA. S. Campbell asked for more information on the vinyl lettering at the windows – K. Kraus responded that the lettering will be 5" high in gold at the top and bottom of each of the 4 windows. J. Allein told K. Kraus that he still needs to go to the Building Department for permits and Certificate of Occupancy.
