- i. Dave Hardy from the Lancaster Presbyterian Church (LPC) was present and wished to discuss some exterior lighting plans for the church. LPC would like to fix the globe lights next to the main door M. Meyer responded that this is a maintenance item and the LPC does not need a COA to repair those lights. LPC is exploring putting floodlights in that were previously installed to light up the building at night. M. Meyer responded that a COA would be needed for this item. The last item was that the LPC is exploring putting holiday lights on the church during the "Light Up Lancaster" season on the front or front and sides of the church. M. Meyer stated that as long as the lights were seasonal the Board would have no problem with seasonal lighting, but requests that the LPC stay in contact with the HPC regarding these lights.
- ii. J. Allein updated the Board on the status of the Community Development Corporation's property on West Main Street. The property has been listed for sale.
- iii. Tom Sweeney recently acquired 20 Brookfield Pl. and discussed with the Board his plans to put in a new driveway in the future as it currently has a shared driveway. The Board made note that he will need a COA for this work in the future.
