## MEETING MINUTES December 13, 2017

#### I. Attendance/Call to Order

Roll call indicated that six (7) voting members were present and a quorum existed.

### II. Public Hearings:

a. 63 Central Ave – Art Lazazzero (WildeArt) – Building Addition

Mr. Lazazzero present at the meeting. The HPC discussed the proposal for a building addition to the northern side of the existing building with Mr. Lazazzero. The HPC discussed building materials and preferences such as the preference to have an asphalt shingle roof on the addition with a single gable (not gambrel as shown in the presented drawings. Another topic discussed was the exterior materials, among options discussed were fiber cement panel, vinyl siding and painted CMU block. Code Enf. S. Marshall suggested that Mr. Lazazzero meet with Code Enf. M. Fischione to discuss setbacks and roof height requirements.

MOTION: M. Meyer motioned to table the CoA as submitted. Second by J. Keefe.

MOTION APPROVED: In a vote of six (6) ayes to zero (0) nays.

b. 60 Central Ave.(Rite Aid) – Michael Yost (Yost Neon Displays) – Signage

Mr. Yost was present at the meeting. There are 5 signs to be replaced at the property. The only changes will be new colors and replacement text. J. Keefe asked if there will be new lighting. Mr. Yost explained that there will be no new lighting; all the signs will be replaced as they are currently.

MOTION: J. Allein motioned to approve the CoA with the condition that all the signage remain the same with no changes in lighting. Second by S. Campbell.

MOTION APPROVED: In a vote of six (6) ayes to zero (0) nays.

*Justification: The replacement signage is compatible with the aesthetic of the historic district.* 

c. 5478 Broadway (The Nesting Place) – Linda Latella – Window graphics

Ms. Latella was not present at the meeting. The COA application included color photographs of the window graphics. The HPC had no discussion about the graphics.

MOTION: E. Eckert motioned to approve the COA as submitted. Second by S. Campbell.

MOTION APPROVED: In a vote of six (6) ayes to zero (0) nays.

*Justification: The window graphics are compatible with the aesthetic of the historic district.* 

d. 5483 Broadway – Wayne Marino – Replace front stoop

Mr. Marino was present at the meeting. He explained to the commission his plans to replace the concrete stoop as it exists. He plans to face the walled sides with stone and the top with slate. The HPC discussed their preference for an exposed aggregate concrete sidewalk. Added to the COA was replacement painted wood-frame windows at the two front basement windows.

MOTION: M. Meyer motioned to approve the COA as amended. Second by J. Allein.

MOTION APPROVED: In a vote of six (6) ayes to zero (0) nays.

Justification: The exterior work on the stoop and sidewalk are compatible with the aesthetic of the historic district.
