II. Public Hearings

a. 9 Clark Street – Edward Shanahan (Atlantic Garages) – Garage Demolition

Mr. Shanahan was present at the meeting. He presented plans to demolish the existing garage at the property. The existing concrete pad will be maintained for parking. A letter of approval by the Planning Commission was included in the COA Application.

<u>MOTION:</u> J. Keefe made a motion to approve the demolition of the garage with the same conditions as provided in the Planning Commission letter. Second by M. Meyer.

Justification: The structure is not contributing to the Historic District.

b. <u>1 West Main Street – Gary Jason (RGGT LLC) – Roof Replacement</u>

Mr. Jason was present at the meeting. He explained that the roof replacement will include the turret and the top portion of the rest of the building. It will not include the mansard. The roof will be a 30-yr black architectural shingle to match the mansard.

MOTION: M. Meyer made a motion to approve the COA as presented. Second by T. Sweeney.

MOTION APPROVED: In a vote of eight (8) ayes to zero (0) nays.

Justification: The new roof is compatible with the aesthetic of the historic district.

c. 5483 Broadway - Wayne Marino - Extension of 2017 COA

Mr. Marino was not present at the meeting. The HPC discussed the letter received which discussed
