Roll call indicated that six (6) voting members were present and a quorum existed.

II. Public Hearings

a. 34 Central Ave. – Maxine Grabowski (Happy Cakes Bakery & Cafe) – Signage

Ms. Grabowski was present at the meeting. She explained plans to put up new signage for her new business on Central Ave. The sign will be wooden and engraved with the business name. There was no discussion.

<u>MOTION:</u> S. McNichol made a motion to approve the COA as presented. S. Campbell seconded the motion.

<u>MOTION APPROVED:</u> In a vote of five (5) ayes to zero (0) nays. M. Meyer abstained from voting as he is currently working with Ms. Grabowski's husband through his employer, Flynn Battaglia Architects. *Justification: The sign fits into the aesthetic of the Central Business District and local historic district.*

b. 6 West Main St. – James Everett (PA) – New overhead door

Mr. Everett was present at the meeting. Drawings were presented to the commission explaining the need for a new overhead door at the business. Altering the lighting at the back of the building was discussed, but will be presented for an additional COA in the future. There was no further discussion.

c. 22 St. Joseph St. – George Pease – Exterior improvements

Mr. Pease was present at the meeting. The COA presented includes replacing the windows, filling in 1 of the exterior windows and re-siding this area, painting the house, painting the exterior trim, replacing the front door and repairing the porch railing. E. Eckert asked about the existing pipe handrail on the porch stairs. Mr. Pease explained he would be replacing that handrail with a railing that matches the rest of the porch.

MOTION: S. McNichol moved to approve the COA as presented. T. Sweeney seconded the motion.

MOTION APPROVED: In a vote of six (6) ayes to zero (0) nays.

Justification: The exterior improvements follow the aesthetic of the local historic district.

d. 4 Main St. – Tommy Sweeney – Exterior Improvements

Mr. Sweeney was present at the meeting. The COA presented included new signage above the storefront system, replacement of the rear windows, mounting a Historic District sign on the front of the building, removing the existing non-functional alarm boxes, and the addition of 3 gooseneck light fixtures above the new signage. The commission discussed the location of the new lights underneath the existing windows.

MOTION: S. Campbell moved to approve the COA as presented. S. McNichol seconded the motion. MOTION APPROVED: In a vote of five (5) ayes to zero (0) nays. T. Sweeney abstained from voting as he is the property owner.

Justification: The exterior improvements fit with the aesthetic of the local historic district.
